I want to start the 2022 Economic Development Annual Report by recognizing a pioneer in Economic Development at the City of Kingman and throughout Mohave County, Gary Kellogg. "Our main focus in 2022 was the Airport Capital Improvement Plan (ACIP) which provides for individual airports and federal and state planning agencies on anticipated capital development needs over 3-5 years. This includes preparing estimates for the new proposed project scheduled for the fifth year of the plan. This year's meeting will consist of adding the construction phase of two projects where the scheduled design phase of these projects is already scheduled for Fiscal Year 2028. These projects are Taxiway A rehabilitation, the geometry redesign, and the creation of a dedicated large aircraft run-up area with a blast fence. The Airport Capital Improvement Plan is the primary planning tool for identifying and prioritizing critical airport development and associated capital needs over a five-year period. The plan helps the Federal Aviation Administration and Arizona Department of Transportation budget for projected projects at airports."

## City Sells Land for Snack Company Distribution at Industrial Park

The City of Kingman's Economic Development Department announced in April 2022 a new, local exchange center that broke ground the same month.

The Frito-Lay project was built on a site that was formally known as the Honor Farm. This facility was opened in the mid-1980s by Mohave County as a holding facility to relieve pressure at the Mohave County Jail. In later years, the Mohave County Sheriff's Department used it as a testing facility for recruits. In 2011, the facility was showing major signs of disrepair.

The Economic Development Team realized that there were some potential sites in the Industrial Park that the city owned but would need to be redeveloped to prepare them for potential future sales. This particular site consisted of three concrete buildings, two single-wide trailers, and a lot of dead trees and weeds. After the demolishing project ended, shortly thereafter, a letter of interest was received from the Crosland Barnes Group to purchase the site. The Economic Development Team's forethought allowed the PepsiCo Frito-Lay distribution center to be developed at the Industrial Park.

The project was completed in 2022 by constructing a 5,276 SQ FT building. The project will serve the Kingman market.

## **Economic Impact Analysis Completed**

In 2022, an economic and revenue impact analysis of the Kingman Municipal Airport and Industrial Park was completed to provide a framework for understanding the benefits that the airport and industrial park generate for the City of Kingman and Mohave County. The impacts include operations of the airport and the businesses within the Industrial Park. The results are based on actual airport operations data for the past three years and data on estimated employment at industrial park businesses, as provided by the Kingman airport general manager and economic development director.

#### What is the Economic Impact?

The Kingman Municipal Airport and Industrial Park is comprised of more than 80 businesses and directly employs nearly 2,700 people (about 2,500 full-time equivalent workers). When these businesses and employees spend their money locally, additional jobs are created. As a result, the total number of jobs supported is more than 3,600, and the total economic impact is \$751 million throughout Arizona.

## Bird Scooter Takes Flight in Kingman

On February 1, 2022, the City of Kingman entered into a temporary operating agreement with Bird Rides Inc., a leading provider of electric bikes and scooters. The operating agreement was set up as a pilot program that would enable the City to analyze how this alternative mode of transportation would be received and used by the community and those visiting.

Instead of allowing the scooters to be operated throughout the whole city a phase one pilot area was established so it could be managed and monitored. Currently, the City hosts a fleet of 50 scooters; however, due to charging and repairs not all 50 scooters are typically deployed in the community all at once. Bird has helped people get all around Kingman; check out the rider map!



## **Strong Construction Permit Demand Continues**

Soaring construction demand, inflation, pandemic-related restrictions, supply chain disruptions, labor shortages, and the war in Ukraine brought about rising costs and some uncertainty in 2022. Despite these concerns, Kingman's demand for new construction projects remained strong. Due to the considerable pent-up demand for new construction and the nationwide housing shortage, in many cases, projects were able to pass costs on. New permits for residential and commercial building continued to grow.

In 2019, Group Travel was vibrant and accounted for a significant portion of the travel economy in Kingman. The Kingman Visitor Center alone hosted more than 2,000 groups, from small shuttles to full sized motor coaches. In March 2020, group travel came to a standstill, as it did for the entire country. Trade Shows with a focus on group travel turned virtual, if they existed at all.

That slowly began to change with the first in-person trade show, IPW Las Vegas, America's largest annual travel trade show, which was timidly held in September 2021. Show attendance was approximately one third that of a normal year, but the Kingman Office of Tourism attended and forecast a strong return to Group Travel over the next year.

More regular conventions were soon on the horizon, making it a goal to make up for lost time. The Kingman Tourism attended the Go West Summit in Reno, NV in February 2022. This trade show specifically highlights the Western U.S. states. Kingman Tourism met with 23 domestic and international tour operators and one media rep from Germany.

June 5-9, 2022, Kingman Tourism attended IPW in Miami, FL as a delegate with the Arizona Office of Tourism, meeting with 30 representatives from the U.S., Canada, U.K., Germany, Austria, The Netherlands, France, and China.

Finally, in November 2022, Kingman Tourism attended the National Tour Association Travel Exchange in Reno, NV, meeting with 18 tour operator representatives from the U.S., Canada, and the U.K.

In 2021, the Kingman Visitor Center hosted 292 groups, mostly smaller shuttles or half-full motor coaches. In 2022, the center welcomed 418 groups, a 43% increase year over year. The Kingman Office of Tourism anticipates these numbers increasing again in 2023, continuing its participation in trade shows and encouraging group tourism in Kingman.








